

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to greentravelescape.com, and Green Travel Escape LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Green Travel Escape LLC include greentravelescape.com and GTE. The GTE website is a travel advising site. By using the GTE website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, GTE may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase GTE's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

GTE may also collect anonymous demographic information, which is not unique to you, such as your:

Use of your Personal Information

Sharing Information with Third Parties

GTE does not sell, rent or lease its customer lists to third parties.

GTE may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to GTE, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by GTE. - SSL Protocol

We strive to take appropriate security measures to protect against unauthorized access to or alteration of your personal information. As a result, while we strive to protect your personal information, you acknowledge that: (a) there are security and privacy limitations

Right to Deletion

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.
